
NC NQF Level 5 Qualification:

Anyone wanting to practice as a Principal of a Real Estate Business, has to hold the NC NQF Level 5 Real Estate Qualification [or equivalent]

Prior to taking on the: NC NQF level 5 qualification one needs to:

- Have attained the SSETA Certification against the FETC NQF level 4 Real Estate Qualification [or been exempted by the EAAB] and ...
- Have Written and Passed the EAAB – PDE 4 'open book' examination [One has then earned the designation: Professional Practitioner in Real Estate {PPRE}]

One can then apply to a SSETA Acc. Training provider to do the: NC NQF level 5 Real Estate Qualification [or apply to the EAAB for exemption, if applicable]

Once certificated by SSETA against the NC NQF level 5 Real Estate Qualification:

One is eligible to apply to the EAAB to: Register a Real Estate Business:

1. Select a Real Estate Business name [and get confirmation from EAAB that the name is available]
2. Open a Trust Account and
3. Appoint an Auditor

The Newly Registered Principal – [now holding a Principal Fidelity Fund Certificate {FFC}]

* **has 18 months** to: enrol with the EAAB to **Write and Pass** the PDE 5 'open book' examination

Having Written and Passed the EAAB - PDE 5 examination

[One has then earned the designation: Master Practitioner in Real Estate {MPRE}]

EAAB – PDE 5 Preparatory Session.
